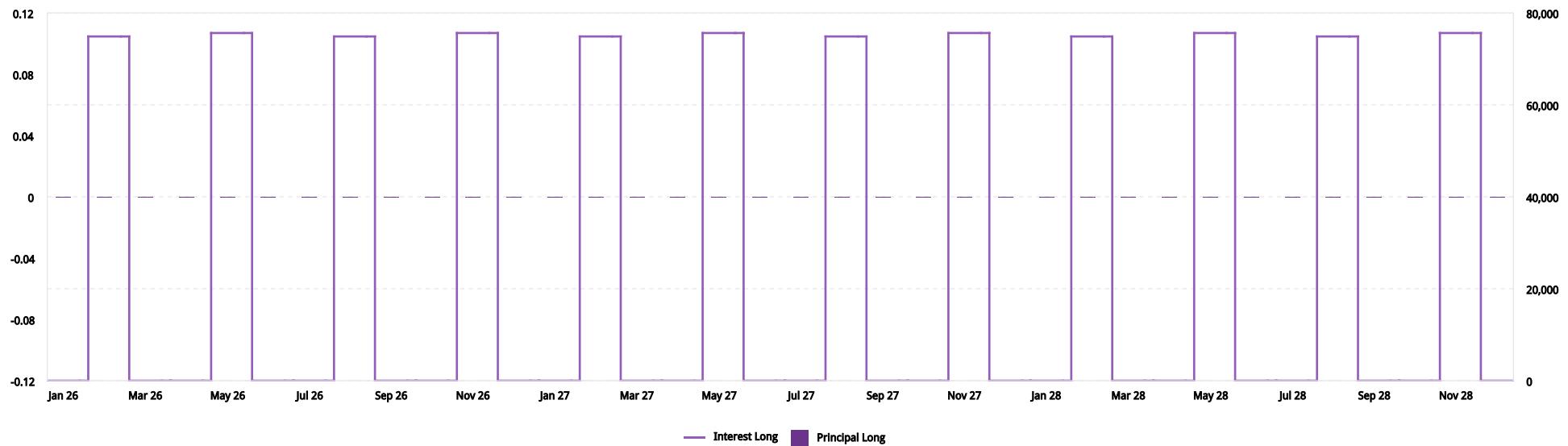

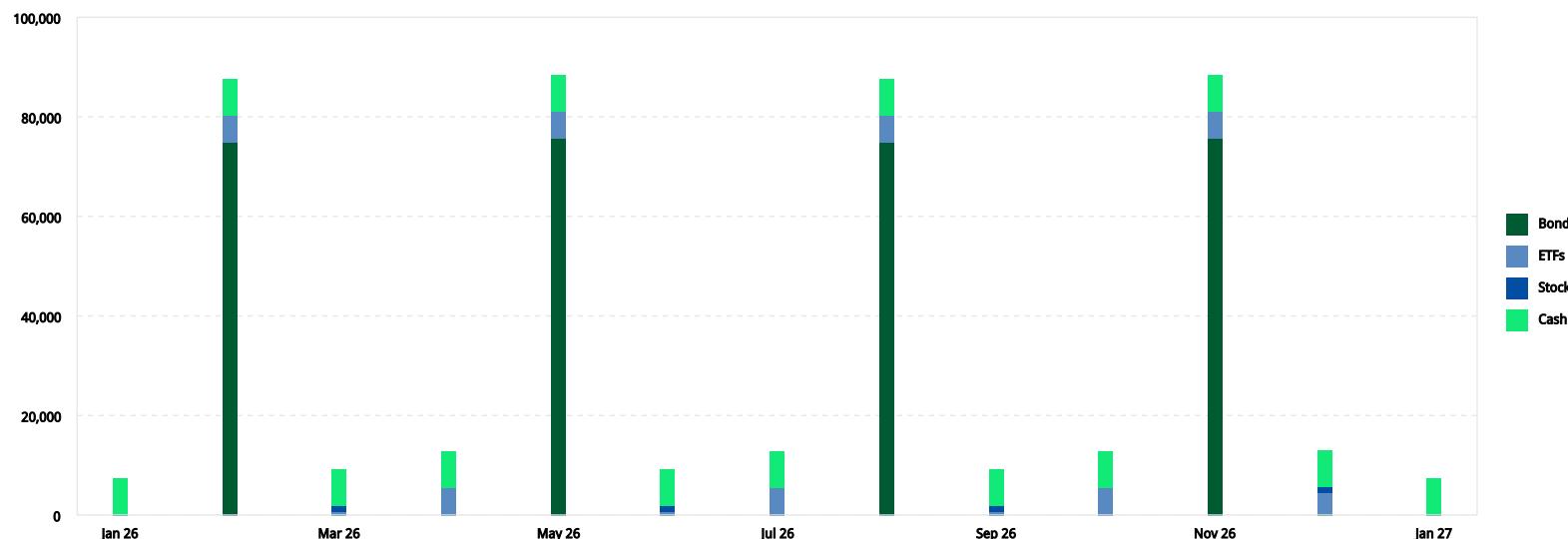

General Notes
